申城即将开启“春花季”

进入立春节气以后,接连多日低温和阴雨交替的天气仿佛挡住了春天的脚步。蛇年元宵节过后,虽然天气依旧寒冷,但期待已久的阳光洒落下来,抚过春景园的每根枝条,把春天的气息传递给了枝上的花芽,申城的早樱也渐渐醒来,将一年里最早的樱花浪漫作为春日礼物送给人们。

在辰山植物园,虽然只是零星绽放,但是点滴粉色在碧绿色草坪的映衬下尤为显眼,经过樱花大道的游客都第一时间被吸引。植物专家告诉记者,这些最先开放的樱花有早樱家族里的寒樱以及河津樱。

寒樱为落叶小乔木,树皮紫褐色,常呈黑色。枝条斜向上伸展,树形成瓶状,小枝较粗;花瓣5枚,伞形花序,先叶开放;萼暗紫红色,萼筒筒状钟形,花柱稍低于雄蕊;幼叶红褐色,成叶上面暗绿色,下面淡绿色微泛白,叶面略呈“V”字形。据介绍,寒樱是辰山樱花园中花期最早的樱花品种,几乎与梅花同期开放,素有“报春樱花”的美称。

专家表示,根据目前的观测,寒樱处于初开阶段,花量不到10%,这是寒樱自2018年冬季引种至今初花期最晚的一年,这和今年冬季1月份天气连续干燥,以及2月份持续低温有关。根据气温统计,2025年2月份上半个月平均气温只有4.38℃,是7年来同期平均气温最低的年份,所以寒樱放慢了开放的脚步,

预计在2月下旬进入最佳观赏期。

而相对于寒樱的姗姗来迟,辰山植物园早樱大道上有几株河津樱却迫不及待地绽放开来,引得游客驻足拍照。仔细看,这些开花的河津樱都搭着支撑和其他的樱花有些区别,据悉,这些都是2024年秋冬季节刚刚安家于此的新成员。

记者从辰山植物园获悉,由于去年9月份的两场历史超强台风,樱花大道有少量的樱花受损,让人心痛不已,为保证樱花的观赏效果,辰山植物园的樱花专家和园艺师们在去年秋季第一时间对受损的樱花进行了补植。新移植的樱花受到环境变化以及较多的修剪以后会出现提前开花的现象,这是其适应环境的自我调节反应。

最令人关注的河津樱大道什么时候能进入花期?专家对此表示,根据花芽萌动的进程来看,河津樱目前正处于芽鳞开裂露出总苞片的阶段。对照历年的物候记录并结合未来半个月的天天气预报,如果2月下旬未出

现最高气温超过20℃的晴好天气,粉色的梦幻河津樱大道在2月份与申城市民相遇的可能性不大。但是会和樱花园其他的最早品种一起,在大自然气候的“总指挥”下,在2月下旬陆续进入初花期前赶后错地来到,在3月里带给我们最浪漫的春天。

记者了解到,樱花分为早樱、中樱和晚樱。早、中樱多为先花后叶,多单瓣;晚樱多为花叶同放,多重瓣。以长三角地区为例,早樱花期3月上中旬,偶尔能早至2月底。通常钟花樱的花期最早,持续时间最长,其余品种的相对花期每年不一。

根据近6年的拍摄记录,早樱代表河津樱的盛花期几乎与上海入春日同步,上海多年平均入春日为3月11日。目前上海的早樱代表品种有河津樱,这是辰山植物园的招牌,大寒樱、钟花樱、迎春樱、大渔樱、椿寒樱等在静安雕塑公园、大宁公园等处也能见到。此外,“阳光”“粉巨人”作为早樱和中樱的过渡品种,其应用前景也比较看好。

今日雨水 山山能作雨 物物解呈春

“山山能作雨,物物解呈春”,北京时间2月18日18时7分将迎来雨水节气。此时节,雨滴落在田野里,草渐绿、花始开,正所谓“东风散为雨,春回万物兴”。

雨水,是春季的第二个节气,也是二十四节气中第一个反映降水现象的节气。民俗学者、天津社会科学院研究员王来华介绍,雨水的含义是降雨的开始,但多以小雨或毛毛细雨为主,且多集中在南方地区。

春雨如丝如缕、如烟似雾,古往今来,常常成为文人雅士笔下的灵感之源,他们以春雨寄情,借春雨抒怀。杜甫说:“随风潜入夜,润物细无声。”韩愈说:“天街小雨润如酥,草色遥看近却无。”朱自清说,“看,像牛毛,像花针,像细丝,密密地斜织着,人家屋顶上全笼着一层薄烟。”

“江南二月多芳草,春在蒙蒙细雨中。”由于春雨最先惠顾南方地区,所以江南春雨的韵味也会最早被感知:或细密如针,或飘飘

洒洒,或檐下滴水,或轻敲窗扉。

每当春雨落下时,空气中常常会夹杂着淡淡的杏花香,于是诗情画意倍添。“杏花是农历二月的当令花。春雨霏霏中,一树树杏花带雨,更显娇柔。”杏花春雨”也是江南的一道亮丽风景线。”王来华说。

自古以来,无数文人墨客争相吟诵杏花春雨。陈与义说:“客子光阴诗卷里,杏花消息雨声中。”晏几道说,“风吹梅蕊闹,雨细杏花香。”而陆游的《临安春雨初霁》写得尤为隽永:“小楼一夜听春雨,深巷明朝卖杏花。”清晨的杏花叫卖声,犹如一曲春意融融的琴调,唤醒了清新,也温柔了岁月。

雨水时节,万物复苏的序曲已经悄然展开。来吧,你不妨走到户外,去和春天相遇,去与春天拥抱。如果你恰在江南,更要好好地感受一番身旁的杏花春雨,那一定是温暖和温柔的极致浪漫。

“雨水”节气 调脾疏肝御寒湿

18日将迎来春季的第二个节气“雨水”,这标志着气温回升、冰雪消融、降水增多。中医专家提醒,这一时期天气乍暖还寒,气候特点以“寒湿”为主,对人体健康尤其是消化功能影响明显,人们宜通过饮食调脾、起居护阳,运动疏肝抵御寒湿邪气,预防季节性疾病。

中国中医科学院西苑医院综合内科副主任医师张艳虹介绍,中医认为,寒湿之气易困脾脏,导致人体脾胃运化功能减弱,出现食欲不振、腹胀、腹泻等症状;且春主肝气,肝气过旺易克脾土,进一步加重消化系统负担。因此,雨水时节多见“风寒湿邪外袭”导致的感冒、咳嗽、鼻炎等外感病;“寒湿滞留关节”易致关节疾病复发;肝气若疏泄失常易发郁结,可表现为情绪波动、抑郁、烦躁甚至失眠。

“雨水节气是春季阳气升发的关键期。”张艳虹说,饮食注意“少酸宜甘、健脾祛湿”,宜多吃山药、红枣、蜂蜜等甘味食物,少吃山楂等酸味食物以免助肝克脾,尽量避免进食生冷、油腻、辛

辣食物或羊肉等过于温补的食物以防加重湿邪。

起居则要注意“春捂护阳,避湿防寒”。张艳虹提示,穿衣宜“上薄下厚”,保护头部、颈项、腰腹和下肢,避免寒从脚起;坚持早睡早起,避免熬夜耗伤肝血;保持居室干燥通风,避免湿气滞留。此外,运动宜以“微汗”为度,避免剧烈运动耗气伤阴,可选择散步、太极拳、八段锦等舒缓运动。
