

# 第十八届上海青年美术大展下周启幕 聚焦AI时代青年艺术新表达

**本报讯** 当人工智能浪潮席卷全球，艺术创作如何守住人文温度？作为上海青年美术最高展，9月13日至11月23日“机·智——第十八届上海青年美术大展”将在刘海粟美术馆拉开帷幕，这场聚焦AI时代艺术创造力的盛会，不仅首次扩容至C·PARK海粟文化广场，更以多元形式解锁青年艺术新表达。

本届青年美展直指当下最前沿的科技与人文议题，在风云际会的大变局中探讨艺术未来会怎样。“在算法重构生活的

当下，我们急需探索人类艺术创造力、想象力和应对能力的各种可能性。”青年美展总策展人、上海市文艺评论家协会副主席林明杰告诉记者，今年青年美展“机·智”这个主题，“机”代表人工智能的技术浪潮，“智”则彰显人类独有的想象力与创造力，二者碰撞出的，是艺术在人机共生时代的无限可能。从4060件海内外投稿作品中脱颖而出的400件入围佳作，生动诠释了这一主题，除传统绘画、雕塑外，AI生成艺术、虚拟现实装置、潮玩设计等新兴品类占据半壁江山。

为了让艺术真正融入城市肌理，本届青年美展打破美术馆围墙，推出多项创新举措构建开放互动的艺术生态。首次携手申通地铁打造4号线艺术环线专列，将优秀作品以高清复制品或数字化形式搬进车厢与站点，让艺术融入通勤生活；“YoungV短视频计划”邀请艺术家自拍创作日常，部分策展人还将直播创作现场，呈现艺术诞生过程；小宇宙App在C·PARK海粟文化广场的中庭广场设主题录音棚，邀请艺术界人士与艺术家深度对谈，内容也将同步上线博客平台，现场的“开麦席”还允许观众分享

观展感悟，亲身参与艺术讨论；本次评选机制也有所创新，丁乙等大咖组成评审团进行不记名投票确保学术性的同时，开幕后也会联合上观新闻开启网络投票，让广大观众也能参与到评选过程中，实现展览“专业+大众”的双重认可。

孵化青年人才，构筑艺术产业链也是美展的重要目标。本届美展首次大规模引入青年艺术媒体人乐梦融15位社会各界青年策展人，他们不仅参与前期策划，更将“站上展览中央舞台”，在展览的各个环节发挥重要作用，确保展览真正反

映青年所思所想。展览明确提出“打通艺术产业全链条”的目标，通过邀请青年藏家、艺术媒体人、KOL等多元角色共同参与。

据悉，自1980年“上海市青年美术作品展览”创办以来，上海青年美术大展已走过45年历程，成为中国历史最悠久的省级青年美术展之一。从1986年“85美术新潮”中由青年人自主筹备、5天完成布展的“奇迹”，到1999年在刘海粟美术馆重启并确立两年一届周期，再到2001年首次面向全国征稿，大展始终与中国当代艺术发展同频共振。

## 上海爱乐乐团新音乐季开幕 搭建中西方音乐沟通的桥梁

**本报讯** 9月4日晚，上海爱乐乐团2025—2026音乐季在勒勒第六交响曲的“锤击”声中拉开帷幕。秉承艺术回归大众的核心理念，本乐季全面下调了门票价格，最低50元(公益票)即可领略经典交响乐的魅力，以20套20场精选音乐会，演出内容涵盖大师与经典、乐游地球、音乐多棱镜、节庆、走近爱乐·室内乐等五大系列，构建一个广阔而多元的音乐版图。

2025/2026乐季上海爱乐乐团以开放的视野，搭建起中西方音乐的桥梁。乐团将带来多部中国首演的西方佳作，包括弗郎西斯·普朗克的《母鹿组曲》、瓦伦丁·西尔维斯特洛夫的《两段对话与后记》、亚历山大·尼古拉耶维奇·斯科里亚宾的《C小调第三交响曲》以及克里斯托弗·潘德列茨基的《波罗乃兹》和圆号协奏曲《冬之旅》，特别是后两首作品，不仅有助于国内乐迷了解潘德列茨基晚期作品，更是一次与国际前沿音乐思潮的同步对话。

上海爱乐乐团的舞台向来是名家荟萃之地，本乐季多位世界级指挥家和独奏家将首次亮相或再度回归。在“大师与经典”系列中，芬兰“西贝柳斯最佳诠释者”奥科·卡姆将亲临上海，一次性呈现西贝柳斯三部里程碑之作：《芬兰颂》《D小调小提琴协奏曲》和《D大调第二交响曲》。奥地利指挥家伊昂·马林、英国指挥家伊沃·博尔顿也将首次来华，分别执棒演绎拉赫玛尼诺夫和莫扎特的经典作品。

中国著名指挥陈燮阳也将在2026年重返上海爱乐乐团音

乐季。上半场加拉·卡拉耶夫的芭蕾舞组曲《七美人》在国内上演次数屈指可数，脱胎于尼扎米波斯诗歌，将阿塞拜疆卡姆旋律、打击乐与俄式配器熔于一炉，也是陈燮阳尤为推荐的音乐会作品。下半场的拉赫玛尼诺夫《E小调第二交响曲》则将尽显指挥早年留学俄罗斯的学术成果，重现唱片里“最浑然一体的俄式线条”。

本乐季上海爱乐乐团将通过一系列创新举措，继续让音乐融入城市生活的每一个角落。

继上个乐季上海爱乐乐团与全球著名乐团——费城交响乐团合作演出室内乐之后，今年双方将再度联手合作大型交响音乐会。其中，由费城交响乐团和上海爱乐乐团联合委约的《京剧幻想》将推出2025版，以两国合作的模式在上海科技大学奏响。

上海爱乐乐团与国家大剧院音乐厂牌NCPA Classics合作的第二张专辑《哈哈图尔第二交响曲》也将重磅推出，纪念世界反法西斯战争胜利80周年。

## 东艺2025/2026秋冬演出季揭幕 金奖巨作《万尼亚舅舅》首秀申城

**本报讯** 2025年9月3日至7日，由图米纳斯与瓦赫坦戈夫剧院联手打造的两部金奖巨作重磅登陆上海东方艺术中心，为东艺2025/2026秋冬演出季盛大揭幕。《叶甫盖尼·奥涅金》将于9月3日至4日载誉归来，备受期待的《万尼亚舅舅》也将在这9月6日至7日首度亮相申城，为观众呈现一场诗意、哲思与美学统一的剧场盛宴。

9月3日下午，东艺举办见面会，瓦赫坦戈夫剧院总经理基里尔·克洛克携塔季扬娜饰演者叶卡特琳娜·克拉姆齐娜、奥尔加饰演者玛丽亚·沃尔科娃与青年

奥涅金饰演者弗拉基米尔·古斯科夫出席，现场气氛热烈。

继2024年史诗巨制《战争与和平》在东艺首演引发广泛关注后，此次瓦赫坦戈夫剧院“连演双作”的回归，不仅延续了东艺与世界名团的深度合作，也成为东艺20周年之际的重要文化献礼，见证这朵“蝴蝶兰”以剧场为桥、以艺术为语，不断拓宽城市文化视野，成为沪上艺术胜地。
