## 故宫博物院迎来建院100周年

一脉文渊红墙铭，百年守望紫禁流芳。故宫博物院建院100周年，这是一份厚重的时代记忆。

百年前，这里重门徐启、百废待兴；抗日战争时期，故宫人携近两万箱文物避敌南迁、以身护宝；新中国成立后，故宫博物院事业发展翻开崭新一页，逐步建立起科学完整的文物收藏、保护、研究、展示及传播体系。

党的十八大以来，以习近平同志为核心的党中央高度重视文化遗产保护传承，故宫博物院迎来了一个高速发展的繁荣时期，焕发出新的时代光彩。

穿越百年历史烟云，巍巍故宫存史博物，拥抱世界阔步未来。

### 从帝王禁苑到人民的博物院

国庆中秋假期，庄严恢宏的午门前，许多游客披着晨光而来。

午门城楼上，“百年守护——从紫禁城到故宫博物院”展览面向公众开放。在这场献礼百年院庆的大展上，人们可以一睹十年难见的《清明上河图》、凝望传承三千多年的亚醜方尊、定格含义隽永的金瓯永固杯……

穿越午门，经内金水桥，沿中轴线前行，人们可以在红垣黄瓦的三大殿，感悟盛世皇朝的合和风范；可以透过东西六宫精巧的陈设，捕捉宫廷生活的温婉气息；可以从养心殿东暖阁卷起的黄纱帘中，追溯百年前的风云沧桑……

每个开放日，都有数以万计的参观者来到故宫博物院，驻足、漫步、惊叹。

一脉文渊，百年传承。1925年10月10日下午2时，故宫博物院在乾清门内举行开幕典礼。会后，清室善后委员

会通电各界，宣布故宫博物院成立。消息传来，北京城万人空巷，人群如潮水般涌向故宫。

然而，彼时的故宫，宫殿年久失修、院落蓬蒿满地。博物馆的事业，起步维艰。

没有藏品，何来博物馆？千绪万端间，第一批守护者从点查宫内“家底”入手，开始了筚路蓝缕的征程。1924年的冬天，北京呵气成霜，点查人员被西北风打得身子直转。他们以组为单位，用最原始的方式查封各宫殿并逐件清点故宫物品。这项中国文物史上规模空前的清点登记工作持续至1930年3月，不仅留下了百万件文物的原始档案，更留下了“国宝公有”的精神传统。

先辈的精神延续百年。故宫博物院文物藏品的清理，在1949年前进行了1次；1949年至2010年，共开展了4次。如今，全院文物藏品总数已经精确到个位。195万件(套)文物分为25大类、百余个子类，共同组成价值不可估量的文化宝库。

**万里南迁护国宝**

要守护这份国家宝藏，不仅需要心细如尘的管理，有时也要有惊天动地的智勇。

长江拍岸。沿江的一处山坡上，重庆故宫文物南迁纪念馆静静伫立，向世人诉说那段可歌可泣的护宝故事。

1933年2月，侵华日军步步紧逼，故宫文物危如累卵。为守护中华文脉，故宫博物院组织动

员，将文物分批南迁，开启人类文化遗产保护史上的一次伟大迁徙。

自华北出发，辗转东南，又西迁至川黔等地。近两万箱南迁文物踏秦岭之飞雪，越湘黔之重山，凌三峡之惊涛，克蜀道之多艰，历程二十余载，行程数万里。

这条铭刻在中华大地的护宝之路上，无数仁人志士拼死捍卫，“人在文物在”的信念矢志不渝。

出土于唐朝、被康有为誉为“中华第一古物”的石鼓，是南迁文物中的代表。被层层包裹的石鼓，装箱后每件重逾2吨。迁移中，这批石鼓随守护者一同经历了轰炸、火灾等险情；回迁时，又遭遇两次车祸。所幸文物无损。

时任国立北平故宫博物院院长马衡后来说：“像这一类的奇迹，简直没有法子解释，只有归功于国家的福命了。”

新中国成立后，南迁文物分三次北返故宫。故宫博物院各项工作陆续恢复并取得新进展。

时光匆匆，距抗战胜利已有80个春秋。这十面意义更加不凡的石鼓现陈列于故宫东侧的皇极殿石鼓馆中。立于石鼓前静静观想，其上犹可分辨的篆文，既是中华文明源远流长的例证，也是中华民族百折不挠、文脉不绝的见证。

正如习近平总书记所言，“博物馆是保护和传承人类文明的重要殿堂，是连接过去、现在、未来的桥梁”。今天的故宫博物院，已成为无数人心驰神往的中华文化地标。

### 科技文保续华章

习近平总书记深刻指出，故宫是了解中国历史文化不可或缺的窗口。

故宫博物院西侧，一排朴素的中式平房，内里却大有乾坤。大名鼎鼎的故宫“文物医院”里，“保护文物功在当代、利在千秋”的理念深入人心。

激光诱导击穿光谱室、有机质文物保护实验室、纺织品修护室、古书画修护室……作为全世界最大的“文物医院”，100多名文物修复领域的专家在此“望闻问切”“治病会诊”。

《五牛图》、马王堆T形帛画、铜奔马“马踏飞燕”、三星堆青铜器……无数国宝背后，都有故宫文物修复师的身影。

迎来百岁生日的故宫博物院，已在奋斗中结下累累硕果。练绝活，文物保护修复体系完善成形。以科技手段为支撑、以传统技艺为基础，形成了文物科技研究、保护修复、制定保护标准三位一体的文物保护修复体系。重创新，科技赋能文物保护传承。超过100万件(套)的文物和古建筑得到数字化采集。强理论，故宫学研究不断深入。一批高校和研究机构的学者成为故宫学研究的生力军；故宫学方向已毕业和在读的研究生数量超过百人。

### “文物+高科技”1:1复制 云冈石窟亮相上海

本报讯 记者 郦亮 一枚石雕佛像的指甲盖残件直径达二十多厘米，由此可以遥想当年佛像的雄浑伟岸；一件雕有江崖海水纹的石钵体态浑圆、工艺精湛，展现出当时石雕技艺的高度发达。在探访昨日开幕的“云海相望——云冈石窟艺术特展”时，诸多令人惊叹的细节映入眼帘，石窟艺术魅力扑面而来。

作为上海文旅2025年下半年重量级文博大展项目之一，该展览于昨日起面向公众开放，展期将持续至2026年3月26日。

云冈石窟位于山西省大同市，是北魏王朝开凿的大型石窟群，距今已有1500年之久，是中国石窟造像艺术的巅峰之作，是中西文化融合的历史丰碑。展览汇聚云冈文物、3D复原石窟、当代艺术作品，VR交互体验活动，以及30分钟的原创数字艺术作品展演，借助激光造影、当代艺术创作等多元媒介，呈现云冈石窟自开凿、保护至当代活化的全历程。

除了真实的文物之外，“文物+高科技”的呈现是此次展览的一大亮点。青年报记者获悉，此次展览分为“双展区”。越看美术馆室内展区分为“化相”“匠道”“光息”“神往”四个单元。第20窟西立佛在沪首现真容。全景光影厅内的“光息”展览单元为观众打造了一场全息云冈石窟光影艺术视觉盛宴。激光造像表演重新定义沉浸式空间。展厅设有4K全景光影、激光雕刻和舞者展演等多种形式，带领观众踏上一段跨越1500年的北魏人文艺术之旅。
